



Tamil Nadu Acts and Ordinanoca.

The following Act of the Tamil Nadu Legislative Assembly received the assent of the Presidents on the 19th July 1994 [and is hereby "published for general information :---

ACT No. 45 OF 1994.

An Act to provide for reservation of seats in educational institutions in the State and of appointments or posts in the services under the State for the Backward Classes of citizens and for persons belonging to the Scheduled Castes and the Scheduled Tribes in the State of Tamil Nadu.

WHEREAS the policy of reservation for the social, economic and educational advancement of the people belonging to Backward Classes of citizens in admissions to educational institutions in the State and for appointments in the services under the State has been under implementation in the State of Tamil Nadu for a long time;

AND WHEREAS the State of Tamil Nadu is a pioneer State in providing reservation for the underprivileged and the first communal Government Order was passed in the year 1921 and the proportional representation for communities was made in the year 1927 in the State of Tamil Nadu;

AND WHEREAS a large percentage of population of Tamil Nadu suffering from social and educational backwardness for many years have started enjoying the fruits of the reservation policy and have been able to improve their lot and attain a higher standard of living;

AND WHEREAS clause (4) of Article 15 of the Constitution enables the State to make any special provision for the advancement of any socially and educationally Backward Classes of citizens or for the Scheduled Castes and the Scheduled Tribes;

AND WHEREAS clause (4) of Article 16 of the Constitution enables the State to make any provision for the reservation of appointments or posts in favour of any Backward Class of citizens which, in the opinion of the State, is not adequately represented in the services under the State;

AND WHEREAS under clause (1) of Article 38 of the Constitution, the State shall strive to promote the welfare of the people by securing and protecting as effectively as it may, a social order in which justice, social, economic and political, shall inform all the institutions of the national life;

AND WHEREAS under clause (2) of Article 38 of the Constitution, the State shall, in particular, strive to minimise the inequalities in income and endeavour to eliminate inequalities in status, facilities and opportunities, not only amongst individuals but also amongst groups of people residing in different areas or engaged in different vocations;

AND WHEREAS under clause (b) of Article 39 of the Constitution, the State shall, in particular, direct its policy towards securing that the ownership and control of the material resources of the community are so distributed as best to subserve the

AND WHEREAS under clause (c) of Article 39 of the Constitution, the State shall in particular, direct its policy towards securing that the operation of the economic system does not result in the concentration of wealth and means of production to the common detriment;

AND WHEREAS under Article 46 of the Constitution, the State shall promote, with special care, the educational and economic interests of the weaker sections of the people, and, in particular, of the Scheduled Castes and the Scheduled Tribes, and shall protect them from social injustice and all forms of exploitation;

AND WHEREAS the representatives of the various political parties and social forums representing backward classes have requested the State Government to consider all the ramifications of the Supreme Court judgment, dated the 16th day of November 1992 in *Indra Sawhney* Vs. Union of India (AIR. 1993 SC 477) regarding reservations under clause (4) of Article 16 of the Constitution and take steps to protect their interests adequately;

AND WHEREAS in the opinion of the State Government, Backward Classes of citizens, and the persons belonging to the Scheduled Castes and the Scheduled Tribes, who constitute the majority of the total population of the State are not adequately represented in the services under the State in proportion to their population in the State of Tamil Nadu;

AND WHEREAS the State Government have, after careful consideration, taken a policy decision that the existing level of sixty-nine per cent reservation in admission to educational institutions in the State and in the services under the State, for the Backward Classes of citizens and for the persons belonging to the Scheduled Castes and the Scheduled Tribes, should be continued for ensuring the advancement of the majority of the people of the State of Tamil Nadu;

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Forty-fourth Year of the Republic of India as follows :----

191. . .

1. (1) This Act may be called the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the Services under the State) Act, 1993.

(2) It extends to the whole of the State of Tamil Nadu.

(3) (a) Sections 2, 3, 4, 5, 6 and 8 shall be deemed to have come into force on the 16th day of November 1992.

(b) Section 7 shall be deemed to have come into force on the 15th day of March 1993.

Declaration.

Short title,

12. It is hereby declared that this Act is for giving effect to the policy of the State towards securing the principles laid down in Part IV and in particular, in Article 38, clauses (b) and (c) of Article 39 and Article 46 of the Constitution.

Definitions.

3. In this Act, unless the context otherwise requires,---

(a) "Backward Classes of citizens" means the class or classes of citizens who are socially and educationally backward, as may be notified by the Government in the *Tamil Nadu Government Gazette*, and includes the Most Backward Classes and the Denotified Communities :

(b) "educational institution" means-

(i) any college or other educational institution, maintained by the State, or receiving aid out of the State funds, or affiliated to any university established by law including an university college and a constituent college;

(ii) any institute or training centre recognised or approved by the Government. Word . Aw.

with the object of preparing, training or guiding its students for any certificate, degree or diploma or other academic distinctions granted or conferred by any University, or authority established or approved in this behalf by the Government;

(c) "Government" means the State Government;

(d) "Scheduled Castes" shall have the same meaning as in the Constitution;

(e) "Scheduled Tribes" shall have the same meaning as in the Constitution.

4. (1) Notwithstanding anything contained in any judgment, decree or order of any court or other authority, having regard to the social and educational backwardness of the Backward Classes of citizens and the persons belonging to the Scheduled Castes and the Scheduled Tribes who constitute the majority of the total population of the State of Tamil Nadu, the reservation in respect of the annual permitted strength in each branch or faculty for admission into educational institutions in the State, for the Backward Classes of citizens and for the persons belonging to the Scheduled Castes and the Scheduled Tribes, shall be sixty-nine per cent.

(2) The reservation referred to in sub-section (1) shall, in respect of the persons belonging to the Backward Classes, the Most Backward Classes and Denotified Communities, the Scheduled Castes and the Scheduled Tribes, be as hereunder:-

TAMIL NADU ENGINEERING ADMISSIONS 2021 ADMISSION TO FIRST YEAR B.E./B.TECH. DEGREE COURSES Information and Instructions to Candidates

Common application to seek admission to Government and Government Aided Engineering Colleges, University Departments and Constituent Colleges of Anna University, Annamalai University and for the seats surrendered by Self–Financing Engineering Colleges in Tamil Nadu under Unified Single Window Admission System for **Indian Nationals.**

1. ALLOCATION OF SEATS IN COLLEGES

a) Category I

I) Seats in B.E. & B.Tech. Degree Courses in Government, Government Aided and Seats Surrendered by Self-Financing Engineering Colleges affiliated to Anna University.

- (i) Seats in Government Engineering Colleges
- (ii) Seats in Aided courses in Government Aided Engineering Colleges
- (iii) Seats in Central Electro Chemical Research Institute (CECRI), Karaikudi

II) Seats in B. E. & B. Tech. Degree Courses in University Departments and *Constituent Colleges of Anna University.*

III) Seats in B. E. Degree Courses in Mechanical Engineering and Civil Engineering (Tamil Medium) in University Departments and *Constituent Colleges of Anna University.*

IV) Seats in B.E. Degree Courses in Annamalai University, Annamalai Nagar, Chidambaram.

- b) Category II
 - (i) Seats in Self-Supporting courses in Government Aided Engineering Colleges
 - (ii) Seats surrendered by Self Financing Engineering Colleges
 - (iii) Seats in Central Institute of Plastic Engineering and Technology(CIPET)

A candidate needs to register **only one online application** for all the courses/colleges/Institutions mentioned above irrespective of the category. Candidates seeking admission under special reservation should also give their option for Special Reservation category along with the main online application. The special reservation categories are given in Section 5.1 and 5.2.

3. ELIGIBILITY

RULES General

Candidates satisfying the eligibility conditions given below as on the last date of submission of online application are eligible to apply. Passing the qualifying examination or changing the religion after the last date of submission of online application shall not be considered.

Nativity

- Tamil Nadu candidates who have passed VIII, IX, X, XI and XII Std. from schools situated in Tamil Nadu are eligible to apply. They need not produce <u>Nativity Certificate</u> for verification.
- ii) Tamil Nadu native candidates who have passed any of the VIII, IX, X, XI and XII Std. or their equivalent examination from schools situated outside Tamil Nadu can also apply. They should produce Original Nativity Certificate only in electronic form/digitally signed e-Certificate at the time of original certificates verification at TNEA Facilitation Centre (TFC).
- iii) Children of Central Government Employees may also apply for admission, irrespective of their native, provided their parents or guardians (only if both parents are not alive) have been serving in Tamil Nadu continuously for the past **FIVE YEARS** at the time of submission of application. This should be supported by producing a certificate from the employer of the parent or guardian, to that effect at the time of original certificates verification at TFC.

- iv) Children of employees in Public Sector or Government recognised Institutions who at the time of submission of application for admission employed in Tamil Nadu continuously for the past five years may also apply irrespective of their domicile. A certificate from the employer stating that the person is a Permanent Employee of the Firm or Institution concerned with evidence like Income Tax return, PF Slips, etc. and is working in Tamil Nadu continuously for the past **FIVE YEARS** has to be produced at the time of original certificates verification at TFC.
- v) Sons and daughters of All India service Tamil Nadu cadre officers are eligible to apply. A Self declaration from the parent in this regard is to be produced at the time of original certificates verification.
- vi) Other State candidates who have studied VIII, IX, X, XI and XII Std. in Tamil Nadu are eligible to apply. They need not produce "Nativity Certificate".

Note:

- Applications without proper Nativity Certificate for Category (ii) without proper employer certificate for categories (iii) and (iv)and without self declaration from the parent for category (v) will not be considered.
- 2. Category (vi) need not produce employer certificate / nativity certificate.
- 3. Categories from (iii) to (vi) will be considered under "Open Competition".

Srilankan Tamil Refugee

As per G.O. (St) No. 172 Higher Education (J2) Dept. dated:29.06.2010 candidates who are Srilankan Tamil Refugee studied in Tamil Nadu will be considered under open competition. They have to produce the following at the time of original certificates verification at TFC:

- (i) Identification certificate from the Head Quarters Tahsildar.
- (ii) Those who have not registered in the refugee camp should produce original passport, visa and letter registered with Police Station.

A pass in the HSC **(Academic: both +1 and +2)** or its equivalent with a minimum average percentage in Mathematics, Physics and Chemistry put together as given below.

Note:

- (i) When the candidates produce grade certificates, they have to produce the actual marks also. Otherwise only the minimum marks applicable to the grades in the eligible subjects (Mathematics, Physics, Chemistry and Fourth Optional Subject) will be taken into account.
- (ii) For minimum eligibility rounding of marks and normalized marks will not be considered.
- (iii) Name of the different boards are listed in Annexure III

Improvement marks: As per the G.O. No. 184 HE (J2) Dept. dt: 09.06.2005 and G.O. (st) No. 143 HE (J2) Dept. dt: 06.05.2008 improvement marks obtained by the candidates including Other State candidates from 2006 onwards will not be considered.

Marine Engineering Branch

The Director General of Shipping, Ministry of Shipping, Government of India, vide Notification No. II. TR (21) 97 dated: 03.10.2002 have issued notification stating that, for Marine Engineering Degree Programme the candidate should pass in 10+2 or equivalent examination with Physics (P), Chemistry (C), Mathematics (M) and English as separate subject with an average of not less than 60 % in PCM. Further a minimum of 50 % in English either at 10^{th} or 12^{th} standard is required for all the candidates.

Other Requirements:

- (i) Maximum age limit 25 years.
- (ii) Minimum Height 157cm.
- (iii) Minimum Weight 48kg.
- (iv) Normal Colour vision.

Before selecting the course the candidate shall ensure that they are medically fit for the course.

The candidates will be admitted only on production of physical fitness certificate obtained from the Medical Officer

authorized by the Director General of Shipping, failing which they will lose the admission.

Mining Engineering Branch

Note to Female candidates opting for Mining Engineering course.

- (1) As per Mines Act 1952, 46(1) no woman shall, not withstanding anything contained in any other law, be employed-
 - (a) in any part of a mine which is below ground;
 - (b) in any mine above ground except between the hours of 6 A.M. and 7 P.M.
- (2) As per Coal Mines Regulation 1957, 86(2) no adolescent or women shall descend or ascend a shaft in a cage or other means of conveyance unless accompanied by one or more adult males.
- (3) They should satisfy the academic norms of Anna University.
